Amnesty International has received further information on six of the above. The appeals of Khairullah Khan, Shorin Khaita Khan, Edjing Abdullah, Anthony Najali, Hassim Iskandar and Asidin Iting were heard by the Supreme Court in Kota Kinabalu on 27 February 1992 which upheld the death sentences previously imposed.

Khairullah Khan, aged 26, and Shorin Khaita Khan, aged 43, had been found guilty on 28 October 1989 by the Kota Kinabalu High Court of trafficking in 175.8 gm of heroin on 12 August 1984.

Hassim Iskandar, aged 34, had been convicted by the High Court in Kota Kinabalu on 15 December 1989, of trafficking in 4,453.51 gm of cannabis on 23 October 1985.

Asidin Iting, aged 34, had been found guilty by the Kota Kinabalu High Court on 5 April 1990, of trafficking in 1,558.28 gm of cannabis on 25 July 1984.

Edjing Abdullah, aged 25, had been found guilty by the Sandakan High Court on 17 November 1989 of trafficking in 387.35 gm of cannabis on 7 August 1986 in Sandakan.

Anthony Najali, aged 32, had been found guilty by the Labuan High Court on 27 September 1990, of trafficking in 391.6 gm of cannabis in Labuan on 22 June 1986.

Amnesty International is seriously concerned that all those named above are awaiting possible execution following trials which may have fallen short of

international standards, and in which they were disadvantaged by language difficulties.

FURTHER RECOMMENDED ACTION: Please send telegrams/telexes/faxes/airmail letters:

- expressing concern that the death sentences imposed on six of the above have been upheld by the Supreme Court in Kota Kinabalu;

- expressing grave concern at allegations that all of the above may have suffered from language difficulties in their initial trials and urging a full investigation into these trials;
- stating Amnesty International's unconditional opposition to the death penalty;
- urging that all these death sentences be commuted and that no more death sentences be imposed.
