Amnesty International has received further information on Hassim Haji Escandar. His appeal was heard in the Supreme Court on 26 February and was rejected. His last remaining avenue of appeal is the Pardons Board of Sabah State, but to Amnesty International's knowledge Pardons Boards in Malaysia have granted clemency on only two occasions.

No further information is available on the other nine cases.

FURTHER RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express and airmail letters

- expressing concern that the death sentence imposed on Hassim Haji Escandar has been upheld by the Supreme Court in Kota Kinabalu;
- stating Amnesty International's unconditional opposition to the death penalty;
- expressing grave concern that Hassim Haji Escandar and the others may have suffered from language difficulties in their initial trials;
- seeking further information on the appeals against the death sentence of the others mentioned above with Hassim Haji Escandar;

- urging that all death sentences be commuted and that no further death sentences be imposed.
