UA 372/91 Ill-treatment/Whipping

MALAYSIA Aaron Cohen Shelton

On 29 October 1991 the Supreme Court in Kuala Lumpur upheld a High Court decision not to exempt Aaron Cohen Shelton, a New Zealand national, from being whipped six times by the rotan (a large cane). Aaron Cohen Shelton aged 24, had been sentenced to life imprisonment and ordered to be whipped six times on 1 September 1987 for possession of 34.61 grams of heroin. Amnesty International does know exactly when he will be whipped but it is thought to be imminent.

## BACKGROUND INFORMATION

Section 39A of the Dangerous Drugs Act 1952 provides a mandatory six strokes for those convicted.

Amnesty International opposes corporal punishment, which it considers to constitute a cruel, inhuman and degrading treatment which contravenes international human rights standards. Article 5 of the Universal Declaration of Human Rights states that "No one shall be subjected to torture or to cruel, inhuman or degrading treatment or punishment. It is also prohibited under the UN Convention against Torture and Other Cruel, Inhuman or Degrading Treatment or Punishment, Article 7 of the International Covenant on Civil and Political Rights and Principle 6 of the Body of Principles for the Protection of All Persons under Any Form of Detention or Imprisonment.

## RECOMMENDED ACTION: Telegrams/telexes/faxes/airmail letters:

- expressing concern that Aaron Cohen Shelton's sentence has been upheld;

- stating your belief that whipping is a cruel, inhuman and degrading punishment which contravenes international human rights standards;

- urging the government to end the application of corporal punishment and to repeal the legislation which provides for whipping.
