## NEPALRajendra Dhakal (m), 30, lawyer, human rights defender

Amnesty International remains concerned for the safety of Rajendra Dhakal, a lawyer and human rights defender, whose whereabouts remain unknown since he was reportedly arrested by police on 8 January 1999 in Tanahun District. There are fears that he may be tortured in custody.

A habeas corpus petition was filed in the Supreme Court in January on Rajendra Dhakal's behalf. At a hearing of the petition on 26 January, the court issued an order to the authorities to produce the detainee in court. The authorities responded by denying that he had been arrested. At a further hearing on 23 March the Supreme Court ordered Police Headquarters to search for Rajendra Dhakal at all places of detention in the country.

In their response the police stated that Rajendra Dhakal had been charged with the murder of a police inspector and that the case was pending at the Tanahun District Court.

At a further hearing on 11 May the government attorney was ordered to present the details of the case pending against Rajendra Dhakal in the Tanahun District Court to the Supreme Court. A date for the next hearing of the petition at the Supreme Court has not yet been decided.

## FURTHER RECOMMENDED ACTION: Please continue to send telegrams/telexes/faxes/express/airmail letters in English or your own language:

- expressing concern for the safety of Rajendra Dhakal, whose whereabouts remain unknown following his arrest by police on 8 January 1999;
- urging the government to take immediate steps to investigate his fate and whereabouts;
- urging that, if he is found to be in detention, he be promptly charged with a recognizable offence, or immediately released, and that steps be taken in the meantime to safeguard his physical integrity;
- calling upon the government, if he is in detention, to allow him immediate access to his family, legal counsel and medical care;
- expressing concern at the human rights situation in Nepal and appealing for an immediate halt to human rights violations.
