PAKISTANHumayun Far, journalist

A hearing of the habeas corpus petition relating to Humayun Far's incommunicado detention took place on 8 July 1997. The prisoner was not brought before the Rawalpindi bench of the Lahore High Court as had been directed by the judge on 5 July. However, contradicting its earlier statement that Humayun Far was not being held by any state agency, including the army, a state representative reportedly said that Humayun Far was in the detention of military intelligence. He did not explain on what legal grounds he is being held nor where he is detained.

The court directed that the state should clarify on 14 July on what legal grounds Humayun Far is being detained and insisted that Humayun Far should be seen by the judge.

To Amnesty International's knowledge there are at present no criminal charges against Humayun Far. His whereabouts continue to be unknown. Humayun Far's family continues to fear for his physical safety.

The Pakistan government's continued failure to comply with High Court directives and to produce the prisoner at the hearings is in clear breach of provisions of the Constitution of Pakistan and the Pakistan Code of Criminal Procedure. These forbid arbitrary detention and require the detaining authority to bring the prisoner before a magistrate within 24 hours of arrest.

RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express/airmail letters in English or your own language:

- urging the authorities to immediately disclose the whereabouts of Humayun Far and to provide him access to a lawyer and to his family;
- urging the government to ensure that Humayun Far is not subjected to torture or other forms of ill-treatment;
- urging the authorities to immediately and unconditionally release him as a prisoner of conscience.
