Amnesty International is concerned for the safety of the five Tamil men named above, who are all farmers from Cithandy Village in Batticaloa District. The five were reportedly arrested on 24 December 1993 near the Santhanamadu River, Kudavaddaikadu, Batticaloa District, by army personnel belonging to the Mullivedduvan army camp. Their whereabouts remain unknown.

Relatives have informed the Batticaloa Peace Committee and have made inquiries at the Pullipainjakal (Tiger Leaf Rock) army camp where the five were believed to have been taken. The commanding officer at the camp denied that they were detained there.

BACKGROUND INFORMATION

In the northeast of Sri Lanka, the armed conflict between government security forces and the LTTE, which is trying to establish a separate Tamil state, continues. The number of "disappearances" reported from northeastern Sri Lanka has decreased significantly in the past year. The security forces do not necessarily acknowledge arrests at first, but whereas previously unacknowledged arrests often proved to be long-term "disappearances", more often now prisoners are eventually traced in custody. Some, however, have not been traced.

RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express and airmail letters either in English or in your own language:

- asking for information on the whereabouts of the five Tamil men named above who were reportedly arrested on 24 December 1993 near the Santhanamadu River, Kudavaddaikadu, Batticaloa District, by army personnel from the Mullivedduvan army camp;
- urging that a full, impartial investigation be held to establish their whereabouts;
- seeking assurances that if they are in custody, they be humanely treated and that they be given immediate and regular access to relatives and a lawyer.
