On 21 August 1995 a third special appeal on behalf of Su Chien-ho, Liu Ping-lang and Chuang Lin-hsiung was rejected by Taiwan's Supreme Court. Amnesty International is deeply concerned at reports that the three prisoners now face imminent execution. It has written to President Lee Teng-hui and Minister of Justice Ma Ying-jeou urging them to use their authority to prevent the executions.

In early August Shihlin District Prosecutor's office is reported to have decided not to charge the four police officers accused of torturing the three prisoners, citing a lack of evidence. Amnesty International continues to call for an independent investigation into reports that the three prisoners were tortured during interrogation and convicted largely on the basis of confessions extracted under torture.

The executions appear imminent, in spite of three special appeals by the Prosecutor General, Chen Han, and expressions of concern from lawyers, parliamentarians and non-governmental organizations in Taiwan, together with thousands of appeals from members of Amnesty International's Urgent Action Network. The latest, disappointing news is of deep concern to the organization which opposes the death penalty in all cases and is particularly concerned at reports that these three prisoners were tortured and denied a fair trial.

FURTHER RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express/airmail letters in English, Chinese or your own language:

- urging President Lee Teng-hui to exercise his constitutional power to commute the death sentences imposed on Su Chien-ho, Liu Ping-lang and Chuang Lin-hsiung; urging the Minister of Justice to order an independent investigation into reports that the three prisoners were tortured during interrogation and that their confessions were extracted under torture;
- calling for the results of this investigation to be made public and any official found responsible for torture or ill-treatment to be brought to justice; expressing deep concern at the use of the death penalty in these cases, in view of widespread concern that the prisoners were tortured and tried unfairly; expressing opposition to the death penalty in all cases and seeking its abolition in law.
