Abstract: This report is about Kenyan women's determined struggle for their rights and the government's responsibility for continuing human rights violations. It is part of AI's worldwide campaign for the protection of women's human rights. It starts by outlining the political context in which abuse of women's human rights occurs. The concerns covered include: women imprisoned and harassed for dissent (the Mothers' hunger strike; the persecution of relatives of government opponents; persecution of women activists); torture, rape and ill-treatment, including rape of refugees; and abuses, including killings, committed in the context of the violence which erupted in late 1991, mainly in the Rift Valley and Western Provinces.

Title:Sudan: Women's human rights: an action report

Abstract:This report draws attention to the human rights violations suffered by women in Sudan. Women in Sudan face abuses by both the government and armed opposition groups. In the war zones of southern Sudan and the Nuba mountains, there are reports of widespread massacre, rape and enslavement of women. At least three million people are displaced because of the war. Outside the war zones, women have had personal and political freedoms destroyed. Since its coming to power in 1989, the military government has set about attempting to mould society according to its own interpretation of Islam. Women activists have been detained and ill-treated and women have been punished for wearing clothes not considered decent or for brewing alcohol. The report concludes with a list of letter writing suggestions for letters to the Sudan authorities and to armed opposition groups, asking them to safeguard women's human rights.

Title:Brazil: The Candelaria Massacre and Wagner dos Santos

Abstract:AI is concerned for the safety of Wagner dos Santos, 22, the only adult witness to testify at the trial of those accused of killing seven street children and one youth in July 1993 in the so-called "Candelaria Massacre". Based mainly on Wagner dos Santos's testimony, three military police officers have been charged and are to be tried for the killings in August. Wagner has suffered attempts on his life and has received death threats. After an attempt to kill him on 9 December 1994 he had to be hospitalized; while in hospital he continued to be harassed and receive death threats; he was moved to a different hospital in April 1995. He is now living in a so-called Witnesses Safe House, where conditions are reportedly poor. Relations between him and military police assigned to protect him are reported to be tense. AI is pressing the authorities to protect Wangner dos Santos; AI is concerned also for other child and youth witnesses in this trial, who currently do not receive state protection

Abstract:Reverend Orson Vila Santoyo, a Pentecostal minister belonging to the Assembly of God Evangelical Pentecostal Church in Camaguey, Cuba, was arrested in his home on 25 May 1995. Abstract:This report is about AI's serious concern at the apparent failure of the authorities fully to investigate the circumstances surrounding the death of Efraín Bamaca, a leader of the armed opposition who "disappeared" in March 1992. The army said that he died in combat but there are strong indications that he died in custody. Efforts to clarify his fate have been hampered by the military, and senior government officials do not appear to have done everything within their constitutionally-defined responsibilities to assist investigations. Recent attempts to excavate a site at a military base where, it is suggested, Efraín Bamaca is buried, have met with a series of obstacles. Those involved in investigating the case have reportedly been threatened.

His relatives were told on 27 May that he had been transferred to hospital; when they got there they were told that he had been dead on arrival. Two autopsies were reportedly carried out. The second, requested by his family, found that the cause of death was "multiple wounds caused by a blunt instrument, as a result of the torture suffered by the victim". Abstract:The annual conference of the International Labour Organization (ILO) takes place in Geneva, 6-23 June 1995. Indonesia will again come under scrutiny for its treatment of workers. AI believes that continuing violations against workers in the year since the labour riots and violent demonstrations in Medan (April 1994) suggest that much needs to be done to protect those who defend workers' rights. The report describes restrictions on trade union activity in Indonesia. It also discusses the cases of those imprisoned after the Medan riots, three of whom remain detained. AI does not condone acts of violence committed during demonstrations but is concerned that the authorities have used the demonstrations as a pretext to intimidate and imprison those peacefully defending workers rights. Also covered are concerns about ill-treatment in arbitrary detention and the investigation into the death of Marsinah, a female factory workers murdered in May 1993.

Title:Sri Lanka: Security measures violate human rights

Abstract:This report reviews Sri Lanka's security legislation from the perspective of the guarantees provided in the International Covenant on Civil and Political Rights (ICCPR). It comments briefly on AI's current human rights concerns in Sri Lanka and then examines in detail the various emergency regulations pertaining to, inter alia, detention, post mortem and inquest procedures and admissibility as evidence of statements made to the police. It also examines the provisions of the Prevention of Terrorism Act. While recognizing that, since the coming to power of the new government, the security forces have so far refrained from resorting to the large-scale violations reported in the past, AI is concerned that certain of these security measures continue to provide a ready context for violations. The report also comments on a number of existing and recently announced measures for the prevention of human rights violations.
