The authorities now acknowledge that Yavuz Y_lmaz is being held in police custody. They state that his detention has been registered in the records of the Prosecutor's Office at Istanbul State Security Court, and that he has been transferred to Elaz__ for interrogation. No further details are currently available.

It is feared that Yavuz Y_lmaz is being interrogated under torture while being held incommunicado at Elaz Police Headquarters.

FURTHER RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express and airmail letters in English or your own language:

- seeking assurances that the lawyer Yavuz Y_lmaz, who was detained in Istanbul on 29 April and later transferred to Elaz__, is not subjected to torture or any other form of ill-treatment;

urging that he is interrogated not by the police, but by the Elaz____ state prosecutor only, in accordance with legislation governing the legal profession;requesting to be informed of any charges brought against him.
