## EXTRA 57/93 "Disappearance"/Fear of Torture 15 June 1993

TURKEY: Ma\_allah Suba\_\_\_ Burhan Suba\_\_\_

Amnesty International is concerned for the safety of Ma\_allah Suba\_\_ and Burhan Suba\_\_ who it is believed are being held in secret detention at the Anti-Terror Branch of Istanbul Police Headquarters. The organization believes that they may be being interrogated under torture, and that they may be at risk of "disappearance".

On 7 June 1993 Ma\_allah Suba\_\_, Burhan Suba\_\_ and their elder brother Metin Suba\_\_ were taken into custody from their home in the Ba\_c\_lar district of Istanbul and taken to the Anti-Terror Branch of Istanbul Police Headquarters. The following day Metin Suba\_i, who claims he was beaten and subjected to *falaka* (beating on the soles of the feet) while in police custody, was released. On 15 June lawyers checked the record of prisoners held by the Anti-Terror Branch, but the names of the brothers had not been entered.

It is believed that these detentions may be part of current security operations in Istanbul against the illegal Kurdish Workers' Party (PKK), an armed opposition organization.

## BACKGROUND INFORMATION

There have been at least seven "disappearances" in Istanbul during the last two years. Most of these were people who were apparently suspected by police of being active in illegal armed political organizations. Although the police are required by the Turkish Criminal Procedure Code to record any detention with the prosecutor and to notify detainees' families, Istanbul police frequently hold detainees for days without carrying out the proper procedures. This causes considerable anxiety to the family, contributes to the practice of incommunicado detention (cited by the United Nations (UN) Special Rapporteur as a major contributory factor to torture), and makes it difficult for lawyers to monitor possible "disappearance" cases.

Turkey ratified the European Convention for the Prevention of Torture on 25 February 1988 and the UN Convention Against Torture on 2 August 1988. Following a programme of visits to Turkish police stations in 1990, 1991 and 1992, the European Committee for the Prevention of Torture (ECPT - established by the Council of Europe) reported: "In the light of all the information at its disposal, the ECPT can only conclude that the practice of torture and other forms of severe ill-treatment of persons in police custody remains widespread in Turkey and that such methods are applied to both ordinary criminal suspects and persons held under anti-terrorism provisions".

Most allegations of torture relate to ill-treatment of detainees in police custody during their initial interrogation when they are usually denied access to relatives or a lawyer. New legislation to shorten the maximum detention period came into force on 1 December 1992. Now non-political detainees may be held for up to eight days before being formally charged or released. Detainees held on suspicion of political offences may be held without charge for up to 15 days. In the provinces of southeast Turkey which are under emergency legislation the maximum detention period for political detainees may be doubled to 30 days.

- requesting that their lawyers and families are informed without delay of their place of detention and that they be granted access to them;

- urging that the detainees Ma allah and Burhan are not subjected to torture.
