On 29 March 1996, the above-named detainees, plus four others, were taken to Istanbul State Security Court. Ali H\_d\_r Polat, Ibrahim Çiçek, Füsun Erdo\_an and Hac\_ Orman and the four others were formally arrested on charges of membership of an illegal organization and committed to Sa\_malc\_lar Prison in Istanbul. The others were released pending trial on similar charges.

At a press conference, held on 2 April at the Istanbul office of the Human Rights Association, Sabahat Karahan, Do\_an \_ahin and Zeynel Ye\_il alleged that they had been tortured while in police custody in Istanbul. Torture methods included being suspended in a crucifixion position, electric shocks, being subjected to pressurized cold water, being choked by having a bag pulled over the head, sexual harassment, threats of rape, and indiscriminate beating. Allegedly all fellow-detainees were subjected to such torture.

## FURTHER RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express/airmail letters in English or in your own language:

- expressing deep concern about the torture allegations made by Sabahat Karahan, Do\_an \_ahin and Zeynel Ye\_il following their detention in Istanbul between 15 and 29 March;
- urging that an impartial and thorough investigation be carried out without delay into their allegations and that those responsible for human rights violations be brought to justice;
- requesting to be informed of the outcome of the investigation.
