Amnesty International has been informed that Incigül Ba\_el was handed over to her parents on 4 May. There is no further information as to her current health situation.

However, detainees taken into police custody in connection with 1 May demonstrations and since released have reported that Mehtap Kuruçay was seen to be in a very poor state due to torture.

## FURTHER RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express/ airmail letters in English or in your own language:

expressing concern at reports that Mehtap Kuruçay was seen in ill-health in police custody allegedly due to severe torture;
seeking assurances that Sabiha Budak, Mehtap Kuruçay and Filiz Öztürk, held since the early hours of 3 May in incommunicado detention at the Anti-Terror Branch of Istanbul Police Headquarters, are not being subjected to torture or any other form of ill-treatment;

- requesting to be informed of any charges against them.
