Amnesty International has been informed that Tacettin Demir was released on 22 July 1993. So far no details are available about his treatment in police custody. No further appeals on his behalf are required at this stage.

Nezahat Özmen reportedly was severely tortured in spite of her seven-months pregnancy and had to be transferred to hospital due to her deteriorating condition and the possibility of a miscarriage. However, it is alleged that the police came to the hospital and insisted that she be taken before a judge and formally arrested, although she was still in need of continuing medical treatment. She was then committed to Mardin prison.

FURTHER RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express and airmail letters either in English or in your own language:

- urging that Nezahat Özmen, who is seven months pregnant, reportedly in ill-health after torture and currently held in Mardin prison, be allowed all medical treatment she may require, by a doctor of her choice;
- calling for an immediate, full and impartial investigation into the alleged torture of Nezahat Özmen at Mardin Police Headquarters between 16 and 19 July 1993:
- requesting to be informed of the charges against her.
