Ahmet Düzgün Yüksel was released on 26 June 1995, but Sabahat Varol is still being held at Istanbul Police Headquarters.

Ahmet Düzgün Yüksel reported to Amnesty International that he and Sabahat Varol were taken to the Anti-Terror Branch of the Istanbul Police Headquarters on the evening of 20 June 1995. There he says that he was subjected to hanging by his wrists during the first session of interrogation.

Ahmet Düzgün Yüksel believes he was released due to public pressure in Turkey and from abroad. He wishes to thank all those who participated in that pressure.

# RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express/airmail letters either in English or in your own language:

- expressing concern for the safety Sabahat Varol who is being held at Istanbul Police Headquarters;
- calling for her to be given prompt access to family and legal counsel;
- seeking assurances that she is not being subjected to torture or any other form of ill-treatment;
- urging that she be brought promptly before a judge;
- asking to be informed of the charges brought against her.
