TURKEY: Ferhat Tepe, correspondent for the daily newspaper Özgür Gündem in Bitlis

Amnesty International has learned of the death of Ferhat Tepe. On 5 August 1993, a body was found by a fisherman in Hazar lake near Elaz\_\_. The body was taken to the nearby town of Sivrice, and later that day on to the State Hospital in Elaz\_\_. Although Elaz\_\_ Police Headquarters were in possession of photographs of Ferhat Tepe which had been given to them by his father, and should therefore have been able to identify the body, the body was subsequently interred in Elazi\_ Cemetery as an "unknown person". There are numerous security forces' checkpoints and roadblocks on the road between Bitlis and lake Hazar and it is claimed that nobody could pass through them without the security forces knowing.

After receiving an anonymous telephone call on 9 August, the family travelled to Elaz\_\_ and, using photographs of the drowned person, identified him as Ferhat Tepe. The body was exhumed and reportedly found to have bruises around the neck and traces of blows about the body. The family have not yet received the autopsy report.

Ferhat Tepe was buried in Bitlis on 10 August.

- expressing your dismay at the murder under unclarified circumstances of yet another journalist from the newspaper <u>Özgür Gündem</u>: Ferhat Tepe abducted in Bitlis on 28 July 1993 and found dead some 250 kilometres away in lake Hazar on 5 August;
- calling for immediate release of the autopsy report;
- urging an immediate, full and independent investigation into the allegations surrounding his death;
- requesting to be informed of its methods and findings.
