TURKEYDüzgün Zengin, veterinary student, aged 20

Amnesty International remains concerned for the safety of Düzgün Zengin, who has not been seen since 13 August, when police raided a house in Izmir where he was staying. Please refer to the original action for full details and note revised recommended actions.

**FURTHER RECOMMENDED ACTION: Please send telegrams/telexes/express or airmail letters in English or your own language:**

- expressing concern for the safety of Düzgün Zengin, who was last seen in Izmir on 13 August 1996 and may have been detained following a police operation in Izmir on that date;
- noting that the authorities have denied his detention;
- also noting that since then police in Kocaeli and Istanbul reportedly told detainees during interrogation that he would be killed;
- urging that immediate steps be taken to establish his whereabouts and to inform his family and lawyer of the results without delay;
- asking to be informed of the results of the investigation.
