EXTRA 158/95 Fear of arbitrary killing

On the evening of 21 November 1995, Hakan Güler, Kadri Tursun and Köksal Gümüwere abducted from a minibus by armed members of the PKK (Kurdish Workers' Party) in the evening of 21 November 1995. The three were travelling in a minibus from Diyarbak_r, where they had been doing some shopping, to Lice, a small town about 80 kilometres away. Other passengers captured at the same time were released over the following days but the three teachers remain in custody. It is feared that their lives are in danger.

BACKGROUND INFORMATION

The PKK has been fighting Turkish security forces since 1984 in an intense conflict in which more than 20,000 people have been killed, including civilians. Gross human rights violations committed by the Turkish security forces, including torture, "disappearance" and extrajudicial executions, have been thoroughly documented by Amnesty International, which has also, repeatedly and publicly, condemned the PKK's killings of prisoners and civilians and in particular the "policy" of killing teachers declared in 1994. In September and October 1994, the PKK abducted and killed 19 teachers, most of whom were working in small villages in the mainly Kurdish southeast. After strong public and international reaction, the killings halted, but in October 1995 three more teachers -- Huseyin Kocaba_, Ökke_ Kaya and Gürkan Ar_turk -- were captured and killed by the PKK.

During 1995 alone, armed PKK members have killed over 70 civilians and prisoners. Most of the victims are Kurdish villagers who participated in the system of government-armed village guards, and their extended families, including women and children. In a public response to Amnesty International's condemnation of these murders, a spokesperson for ERNK, the National Liberation Front of Kurdistan, the popular front established by the PKK, claimed that the villagers and teachers killed by the PKK were "members of MIT (Turkish intelligence agency)" or village guards, and that "the number of people killed is very limited". In fact, the victims are numbered in their hundreds, and the killings are continuing.

Amnesty International has received no evidence to support the claim that teachers are working to gather military intelligence. Moreover, just as it unconditionally opposes the practice of hostage-taking, Amnesty International opposes the killing of any prisoner - an abuse forbidden under Common Article 3 of the Geneva Conventions (1949), which the PKK has in the past announced it would respect.

RECOMMENDED ACTION: Please send telegrams/faxes/express/airmail letters in English or your own language:

- expressing concern for the safety of the teachers Hakan Güler, Kadri Tursun and Köksal Gümü_, held by armed PKK members since 21 November 1995;
 pointing out that Common Article 3 of the Geneva Convention (1949) forbids
- pointing out that Common Article 3 of the Geneva Convention (1949) forbids warring parties to harm those who are not taking part in a conflict, in particular civilians and prisoners.
