WE FURTHER CALL UPON THE UK GOVERNMENT TO FULFILL ITS OBLIGATIONS UNDER DOMESTIC AND INTERNATIONAL HUMAN RIGHTS LAW AND END THE PRACTICE OF ENTERING INTO MEMORANDA OF UNDERSTANDING (CONTAINING SO-CALLED DIPLOMATIC ASSURANCES) IN ORDER TO FACILITATE THE DEPORTATION OF INDIVIDUALS TO COUNTRIES WHERE THEY FACE A RISK OF TORTURE OR OTHER ILL-TREATMENT.
