According to a Croatian prisoner-of-war recently released from Sremska Mitrovica prison in Vojvodina province in Serbia, Marin Vidi_-Bili, representative of the Croatian government in Vukovar at the time of its occupation by federal army and Serbian forces in November 1991, is currently held in Sremska Mitrovica prison.

On 6 January 1992, a Croatian opposition party leader stated that he had learned that the journalist Siniša Glavašavi_ was being held in Belgrade. Amnesty International has not received any information about the fate of Branimir Polovina. All doctors from Vukovar hospital who were detained are reported to have been released.

Croatian official sources have stated that 185 hospital staff from Vukovar hospital, together with some 500 patients from Vukovar hospital and Borovo Selo, who were detained at the same time as the above persons have still not been released from detention. They were reportedly held in improvised detention centres under the control of the federal army in prisons, barracks and deserted farms, in places such as Sremska Mitrovica, Begejci and Staji_evo near Zrenjanin (Vojvodina). Prisoners released from these places of detention have described extremely harsh conditions, with prisoners exposed to severe cold, given poor food and subject to arbitrary beatings by guards. The conditions of hygiene and medical treatment of sick and wounded prisoners have been described as appalling. Recently the detention centres in Begejci and Staji_evo have been closed; some of those held there are believed to have been transferred to Sremska Mitrovica, but the whereabouts of many others is uncertain.

FURTHER RECOMMENDED ACTION: Telegrams/faxes/airmail letters:

- urging the release of Siniša Glavaševi_, Marin Vidi_-Bili, Branimir Polovina and all patients and medical staff from Vukovar hospital and Borovo Selo who were detained on 20 November 1991 and who have neither used nor advocated violence;

- expressing concern about reports of the harsh conditions in which they are said to be held, and urging that all sick and wounded prisoners be given adequate medical care and conditions for recovery.
