People in Belarus risk being fined or imprisoned for up to two years simply for participating in the activities of an unregistered non-governmental organization, under Article 193-1 of the Criminal Code. The authorities frequently refuse to register organizations, so this means that political and human rights activists are increasingly susceptible to prosecution.

Article 193-1 is used by the authorities to punish activists for peacefully exercising their rights to freedom of assembly, association and expression.

Since Amnesty International started campaigning for the release of individuals imprisoned under Article 193-1, five people have been released. The Belarusian government appears to be responding to the pressure – so let's keep it up!

### **ARTICLE 193-1 MUST BE ABOLISHED.**

It violates the Belarusian Constitution and is in breach of the country's obligations under international human rights law.



Dear Minister,
