On 15 August 1997 four more journalists, all employees of ORT, Russia's public television station, were detained on the Belorussian-Lithuanian border. Anatoly Adamchuk, Aleksandr Oganov, Valery Astashkin and Uladzimir Kostsin are being kept in solitary confinement in Lida, Grodno region. It is not known whether they have been charged with any criminal offence. Pavel Sheremet and Dmitry Zavadsky have remained in detention since their arrest on 26 July.

The State Committee for Border Troops of Belarus has issued a press statement saying that the detention of the four journalists was due to "the need for further investigation into the circumstances of their unsanctioned stay in the border zone".

Anatoly Adamchuk has subsequently made a televised statement, on 18 August, claiming the trip made by the ORT journalists to the Belarussian-Lithuanian border was part of a wider conspiracy. Anatoly Adamchuk reportedly appeared to be delivering a pre-prepared statement and spoke "like a robot". Sources have implied that he was coerced, possibly physically, into making the statement. There is now some concern that the other five ORT journalists in detention may also be physically coerced into making similar admissions of guilt.

On 20 August Belorussian authorities announced their intention to expel another ORT correspondent, Vladimir Foshenko, from the country. According to a deputy head of the Belorussian Presidential administration, Ivan Pashkevich, Foshenko is regarded by the law-enforcement bodies as an participant in the above alleged violations. Foshenko was sent to Belarus by ORT to cover the story of the detention of Pavel Sheremet and his colleagues.

FURTHER RECOMMENDED ACTION: Please send telegrams/faxes/express/airmail letters in Russian, English or in your own language:

- calling for the charges against Anatoly Adamchuk, Aleksandr Oganov, Valery Astashkin and Uladzimir Kostsin to be made known, and that if they are detained solely on the grounds of seeking to peacefully exercise their right to freedom of expression, they should be immediately released;
- calling for the immediate and unconditional release of Pavel Sheremet, Dmitry Zavadsky, and for the charges against them and Yaroslav Ovchinnikov to be dropped;
- seeking assurances of the security and well-being of the detained journalists and urging that they be allowed to see a lawyer of their choice.
