UA 29/95 Extrajudicial executions / Fear for safety 10 February 1995

GEORGIA Ivan ANTILAVA, his wife and son-in-law (names not known)

Fears for the safety of ethnic Georgians in the disputed Republic of Abkhazia have been heightened by the reported extrajudicial execution of Ivan Antilava, his wife and their son-in-law by Abkhazian police at the end of January 1995. The Republic of Abkhazia, a territory within the former Soviet republic of Georgia, has been the scene of bitter fighting in recent years.

According to a report in the New York Times of 5 February the killings were a revenge attack by Abkhazian police based in Tagiloni, Gali district, after several of their men were killed by unknown assailants in late January. Neighbours reported seeing police enter the house where Ivan Antilava and his family lived, and then discovering their bodies after the police had left. Ivan Antilava had been shot in the head, his wife in the chest and their son-in-law in the stomach and head.

BACKGROUND INFORMATION

The Republic of Abkhazia is situated in the north-west of Georgia. Tension has long existed between sections of the Abkhaz population seeking greater autonomy, and the Georgian Government seeking to preserve Georgia's territorial integrity. Armed conflict broke out in August 1992 when Georgian troops entered Abkhazia and took control of the capital, Sukhumi. The main fighting ended when Georgian forces were eventually forced out of Abkhazia in September the following year, but peace talks have as yet failed to resolve the issue of Abkhazia's status. Hundreds of thousands of Georgians were estimated to have been displaced from Abkhazia during fighting. A small number have returned, mostly to the Gali district.

During the course of the conflict Amnesty International has repeatedly expressed its concern to both sides about allegations of human rights violations. These have included detention, "disappearances" and extrajudicial executions on ethnic grounds.

RECOMMENDED ACTION: Please send faxes/telegrams/express and airmail letters either in English, Russian or in your own language:

- urging an immediate, comprehensive and impartial investigation into the reported killing of Ivan Antilava and two other members of his family by Abkhazian police in Tagiloni at the end of January 1995;
- urging that the results of such an investigation be made public, with any perpetrators identified brought to justice within the norms of international law:
- urging that all appropriate steps are taken to ensure the security of all residents, regardless of ethnic origin.

This is a limited action. Please restrict appeals to 15 per section.
