KAZAKSTANOleg Amiranovich GOROZASHVILI, aged 27

Amnesty International learned on 27 March that Oleg Gorozashvili, who has been sentenced to death for murder, is still alive but remains on death row. He awaits a decision by the authorities on whether to commute his death sentence or to begin judicial proceedings which might lead to the sentence being overturned.

Although a petition for clemency has already been turned down, Oleg Gorozashvili's lawyers and local human rights activists continue to argue that the sentence should be overturned on the grounds of serious investigative and judicial errors, including forced confession. As noted in the earlier follow-up Urgent Action of 27 January, the allegations that such errors took place have already been acknowledged as credible by at least one senior official. International pressure through the Urgent Action network is thought to have played a decisive role in securing the current stay on Oleg Gorozashvili's execution. Discussion of the case by Supreme Court officials is reportedly due within the next two weeks, and renewed international pressure at this time may play an equally important role in preventing the execution of Oleg Gorozashvili altogether.

FURTHER RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express/airmail letters in Russian, English or in your own language: To the President of Kazakstan:

- urging that he reconsider his decision not to grant clemency to Oleg Gorozashvili, and commute this and all other pending death sentences.

To the Chairman of the Supreme Court and the Procurator General:

- urging them to order an immediate judicial review of the case of Oleg Gorozashvili, in view of the allegations of violations of investigative and judicial procedure;
- urging that Oleg Gorozashvili's execution be stayed pending the outcome of this judicial review.
