Sultan KARIBZHANOV, aged 24 KYRGYZSTAN Andrei ARAZOV, aged 23

Sultan Karibzhanov faces imminent execution unless the Presidential Clemency Commission of Kyrgyzstan reconsiders its decision to uphold his death sentence and recommends that the President exercises his constitutional authority to commute the sentence.

Sultan Karibzhanov was convicted, together with his friend, Andrei Arazov, by Chuy Regional Court on 7 February 1994 of the murder of an elderly couple in March 1992. Both were sentenced to death. On 5 April, the Supreme Court of Kyrgyzstan rejected their appeal against their death sentences. Amnesty International has just been informed by the Secretary of the Presidential Clemency Commission that the Clemency Commission has upheld Andrei Arazov's petition for clemency and that the President of Kyrgyzstan has commuted his sentence to 20 years' imprisonment.

However, the Clemency Commission has decided not to grant clemency to Sultan Karibzhanov. It is not clear whether the President has already signed the execution order for Sultan Karibzhanov.

Sources have raised concerns that the court of first instance verdicts are unsound: they report that the only evidence linking Andrei Arazov and Sultan Karibzhanov to the crime were confessions made to law enforcement officers during interrogation, and that they were beaten and intimidated into making these confessions. During their trial the defendants retracted their confessions.

## RECOMMENDED ACTION: Please send telegrams/faxes/express and airmail letters either in Russian, English or in your own language:

- welcoming the commutation of Andrei Arazov's death sentence;
- expressing regret at the Clemency Commission's decision to uphold Sultan Karibzhanov's death sentence, and calling on the Commission to reconsider and to recommend that the President commute his death sentence;
- expressing concern that the verdicts against Andrei Arazov and Sultan Karibzhanov have been called into question, following allegations that the two men were forced to make confessions under ill-treatment during interrogation.
