Amnesty International has received information that up to 200 people have been detained by Turkmen law enforcement officials since the unprecedented anti-government demonstration on 12 July in the Turkmen capital, Ashgabat. They include four people, identified as having been among the organizers of the demonstration, who have been named by unofficial sources as brothers Azhdar and Alamurad Amanmuradov and two people identified only by the surnames Gelenov and Amanov. The detainees are allegedly being held in the police station in Ashgabat's Kopet-dag district. Amnesty International believes that they may be prisoners of conscience, and remains concerned for their safety and well-being.

In reaction to foreign reporting of the 12 July demonstration, the Turkmen authorities put out a statement saying that the demonstration had not been a political protest but an "anti-social provocation" by people "high on drugs and alcohol".

FURTHER RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express and airmail letters in Russian, English or your own language:

- to release from detention immediately anyone involved in the 12 July demonstration in Ashgabat who has been detained solely for exercising their fundamental human rights to freedom of association and expression;
- to explain the reasons for the detention of Azhdar Amanmuradov, Alamurad Amanmuradov, Gelenov and Amanov;
- to guarantee the physical safety and well-being of all persons who have been detained in connection with the 12 July demonstration.
