Amnesty International has learned that Ak-Mukhamed VELSAPAR, Khudayberdi KHALI, Nurberdi NURMURADOV and Aman GURSHAYEV have once again been placed under house arrest. They together with Mukhamed SALAMATOV and at least five other members of the non-violent <u>Agzybirlik</u> political opposition movement were placed under 24-hour house arrest at their homes in Ashgabat, the capital of Turkmenistan, on 2 December 1992 after attempting to attend a human rights conference in Kyrgyzstan. The conference began on 5 December, and all were still under house arrest on 7 December.

Human rights activists Ak-Mukhamed VELSAPAR, Khudayberdi KHALI, Aman GURSHAYEV and Nurberdi NURMURADOV were previously placed under house arrest for around a week at the end of October 1992 after meeting or trying to make contact with representatives of Amnesty International who were visiting Ashgabat, and who were later expelled from the country (see EXTRA 87/92).

The $\underline{Agzybirlik}$ movement has tried three times to register officially, but each time members have been threatened with arrest if they meet for the necessary constituent assembly.

Amnesty International believes that the arrest of these men is in direct violation of their right to freedom of association. Amnesty International is again calling on the Turkmenian authorities to release immediately and unconditionally all those currently under house arrest for attempting peacefully to exercise their human rights.

FURTHER RECOMMENDED ACTION: Please send telegrams/express and airmail letters

in Russian, English or your own language:

- urging the immediate and unconditional release from house arrest of Ak-Mukhamed VELSAPAR, Khudayberdi KHALI, Nurberdi NURMURADOV, Aman GURSHAYEV, Mukhamed SALAMATOV and all others currently so detained for peacefully seeking to exercise fundamental human rights.
