Amnesty International has learned that Aymurad NURYYEV, Mikhail CHIRKUNOV and Saparbay GARAKHANOV were executed on 17 December 1992. It has also learned that their death sentences were passed on 20 November 1992, not 14 November 1992 as originally stated in UA 371/92, and that an appeal was in fact lodged with the Presidium of the Supreme Court. This suggests that the process of appealing and then petitioning for clemency was in this case exhausted in less than four weeks.

FURTHER RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express and airmail letters in Russian, English or in your own language:

- expressing deep regret that the death sentences passed on Aymurad NURYYEV, Mikhail CHIRKUNOV and Saparbay GARAKHANOV have been carried out, and expressing Amnesty International's unconditional opposition to the use of this form of punishment;
- urging that a moratorium be imposed on death sentences and executions pending a comprehensive review of the use of the death penalty in Turkmenistan.
