Arsen Arutyunyan and Danis Sirazhev are believed to be in danger of imminent execution. An appeal against their death sentences has been lodged with the Supreme Court of Uzbekistan, which is expected to make a decision on 20 December.

The two men are the lead singers of a well-known Uzbek pop group, Al-Vakil. They were charged with the April 1998 killing of a famous Uzbek singer, Laylo Aliyeva, and sentenced to death by Tashkent City Court on 3 November 1999 for premeditated, aggravated murder (Article 97 of the Uzbek Criminal Code).

According to the information received by Amnesty International, both men were held incommunicado for two weeks after they were detained, on 3 June 1999 in Tashkent. After he was granted access, Arsen Arutyunyan's lawyer was still not allowed to meet with him in private. The two men confessed to killing Laylo Aliyeva, but there is serious concern that their confessions were extracted under duress. According to reliable sources Arsen Arutyunyan's family was threatened several times. There was also an attempted assault on his sister. Some of his family have fled Uzbekistan as a result.

Amnesty International opposes the death penalty in all cases and without reservation, as a violation of the right to life and the right not to be subjected to cruel, inhuman or degrading treatment or punishment, as proclaimed in the Universal Declaration of Human Rights.

BACKGROUND INFORMATION

Uzbekistan retains the death penalty for eight offences, including aggravated murder. In 1998 the *Oliy Majlis* (parliament) removed the death penalty from the criminal code as a punishment for five other offences.

Amnesty International is seriously concerned that Uzbekistan continues to carry out executions, and this concern is heightened by the fact that a substantial number of men sentenced to death have alleged that they were tortured in pre-trial detention. Conditions on death row have been described by former prisoners as particularly cruel. Amnesty International has consistently pressed the Uzbek authorities to reduce the scope of the death penalty as a step towards total abolition. The organization has also asked that they impose a moratorium on death sentences and executions pending a review of this punishment and that they publish comprehensive statistics on the application of the death penalty.

RECOMMENDED ACTION: Please send telegrams/faxes/e-mails/express/airmail letters in Russian or your own language:

- urging the President to use his constitutional authority to commute the death sentences passed on Arsen Arutyunyan and Danis Sirazhev, as well as all other death sentences that come before him;

- urging that a moratorium be imposed on death sentences and executions pending a comprehensive review of the death penalty;

- expressing concern at allegations that Arsen Arutyunyan's and Danis Sirazhev's confessions were extracted by force and asking the authorities to launch an independent and impartial investigation into these allegations;

- asking for assurances that the safety of both men's families be guaranteed.
