Some 50 Muslim men from the town of Janja and the surrounding area were arrested by the Bosnian Serb authorities on 15 July 1994. Among them were the men named above. Amnesty International has since learned that Sulejman Skoki\_, Halid Velagi\_ and Omer Alibegovi\_, and possibly all the others, were forcibly sent by the Bosnian Serb armed forces to the front line at Lopare, south of Br\_ko, to dig trenches or fight Bosnian Government forces. Halid Velagi\_ and Omer Alibegovi\_ were subsequently wounded by an exploding grenade and taken to a hospital in Bijeljina. Halid Velagi\_ has since returned to Janja, but did not know what had happened to Sulejman Skoki .

Amnesty International has no further information about the fate of the men named above.

Movement in and out of Janja is reportedly strictly controlled by the Bosnian Serb authorities and no one may reach the town or leave it without the authorities' permission.

Amnesty International has also received a report that a curfew is in force in Janja and that those who break the curfew risk being arrested or killed. According to the same report, Bosnian Serb military officials, accompanied by Serb civilians, after having arrested and taken away Muslim men, have allegedly been returning to these homes and raping the women.

Another report received by Amnesty International indicates that the forcible expulsion of Muslims from Bijeljina may be continuing. On 24 July, buses with dimmed windows were reportedly seen passing through Janja, apparently travelling from Bijeljina to Zvornik. Local Muslims feared that they were carrying Muslims who had been taken from their homes by force by the Bosnian Serb authorities. On 24 July Sarajevo radio reportedly claimed that 54 Muslim men had been killed in Bijeljina and that 36 women were also missing.

# FURTHER RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express and airmail letters:

- expressing deep concern about reports that on 15 July Bosnian Serb forces arrested Muslim men from Bijeljina, Br\_ko and Janja, including the above-named men from Janja, some of whom have reportedly been sent to fight, against their will, Bosnian Government forces;
- urging the immediate release of all those who have been detained and forcibly mobilized against their will;
- expressing deep concern about recent allegations that Serb military officials,

accompanied by Serb civilians, have raped women in Janja, after arresting adult male members of their households, and urging that these allegations be investigated and any perpetrators brought to justice.

- expressing concern about reports indicating that Muslims have continued to be forcibly expelled from Bijeljina.
- calling for immediate action to ensure an end to all attempts to make non-Serbs leave their homes, whether by force or intimidation.
