UA 41/96 <u>Ill-treatment / Fear of further ill-treatment</u> 20 February 1996

FEDERAL REPUBLIC OF YUGOSLAVIA(KOSOVO Province)Sejdullah Rashiti, high-school student

Sejdullah Rashiti, a high-school student from a village near Gnjilane, has recently twice been arrested and physically ill-treated by a police officer, who has threatened to take further reprisals against him.

The police officer is one of two officers who are charged with the 1991 killing of Zejnullah Rashiti, Sejdullah's brother. The two officers are accused of having shot dead the young man when he attempted to flee after they stopped him to check his identity card.

In March 1995 the two officers were brought to trial on charges of murder, after Rashiti's family started criminal proceedings against them. The trial was postponed, however, after the family's lawyer filed a request that a third police officer, the commander of the patrol, be included in the indictment. This request was subsequently refused by the public prosecutor. In April 1995 the trial was again postponed because one of the defendants had failed to appear in court. The trial has still not ended.

At least one of the officers remains in active service in Gnjilane. On 10 February 1996 he reportedly arrested Sejdullah Rashiti in the marketplace in Gnjilane, questioned him about weapons, and physically ill-treated him. Three days later, on 13 February, the same police officer reportedly stopped Sejdullah Rashiti in the street and beat him with a rubber truncheon, telling him he would not stop until the family withdrew their charges against him.

BACKGROUND INFORMATION

Police officers in Yugoslavia are rarely convicted, or indeed prosecuted, for serious human rights abuses. In most cases charges are never brought, or criminal proceedings are unduly prolonged. In this case it appears that the investigation against the two officers was initially dropped and was only reopened after the family filed charges.
