YUGOSLAVIA (Kosovo) Ethnic Albanian former police employees

On 19 April 1995, nine ethnic Albanian former police employees were convicted by the Pe_ district court of on charges of seeking to undermine Yugoslavia's integrity by force under Article 116 of the Yugoslav Criminal Code. They were accused of having set up a "parallel" or clandestine ethnic Albanian police force in Kosovo province.

Sherif Shala, Shaban Shala, Gani Hajdari, Dërgut Bibaj and Xhevat Ibraj were sentenced to five years' imprisonment; Vllaznim Shehu to four years'; Idriz Elezaj and Skënder Krasniqi to two years' and Sefer Hasanaj to one year's imprisonment. Those with sentences of under five years were released pending appeal.

It is reported that the accused all denied the charges against them, and said that their activities had consisted exclusively in trade union work on behalf of the Union of (former) Police Employees. The court ruled that a list - allegedly of Serbs and Montenegrins to be liquidated - could not be included as evidence, after defence lawyers objected that it was a photocopy, had not been examined by experts and was not connected with the indictment. The accused and at least one witness stated in court that they had been physically ill-treated or threatened by police officers with the aim of obtaining incriminating statements from them.

Seven other former police employees are currently on trial in Pe_, on the same charges.

On 3 May 1995, a further 44 former police employees are due to go on trial in Prizren, among them Ramadan Ndrecaj, Rexhep Oruçi, Salih Sokoli, Halil Kafexholli and Shaban Dana (whose names have been mentioned in previous follow-ups), again on charges under Article 116. In Gnjilane 28 former police officers await trial and 70 others are still under investigation in Priština.

Lawyers for the defendants have repeatedly stated that following arrest their clients were forced, by physical and psychological ill-treatment, to make self-incriminating statements. Police and state security officers carried out much of the investigation and it appears that records of the injuries suffered by the accused usually do not appear in the files of the investigation.

FURTHER RECOMMENDED ACTION: Please send telegrams/faxes/express and airmail letters:

- expressing concern at reports of the convictions of nine ethnic Albanian former police employees in Pe_ on 19 April in circumstances which effectively denied them their right to a fair trial;
- expressing concern about forthcoming trials of up to 160 others in Pe_, Prizren, Gnjilane and Priština;
- stating that your concerns arise out of the fact that there have been repeated

reports of procedural breaches in these cases and, even more seriously, numerous allegations that the defendants were tortured or severely ill-treated by police officers following arrest with the aim of obtaining self-incriminating statements from them;

- urging that these allegations be thoroughly and impartially investigated and any police officers found responsible brought to justice;
- urging that defendants be granted a fair trial according to international standards, citing, in particular, Article 15 of the Convention against Torture and Other Cruel, Inhuman or Degrading Treatment or Punishment (ratified by Yugoslavia) which states: "Each State Party shall ensure that any statement which is established to have been made as a result of torture shall not be invoked as evidence in any proceedings, except against a person accused of torture as evidence that the statement was made."
