## EGYPTFive men detained in connection with their actual or perceived sexual orientation

At least five men were detained earlier this month because of their actual or perceived homosexuality, in Buhaira province, southeast of Alexandria. Amnesty International fears that they are at risk of torture and ill-treatment.

On about 15 January the Public Prosecutor in the provincial capital, Damanhour, ordered the men to be detained while investigations were carried out into allegations of "habitual debauchery". This charge is used in Egyptian law to criminalize homosexual acts.

The Public Prosecution reportedly ordered the defendants to be medically examined by forensic experts. Amnesty International fears that the men will be forcibly subjected to anal examinations to determine whether they have engaged in anal sex. Such examinations have previously amounted to cruel, inhuman and degrading treatment.

#### BACKGROUND INFORMATION

In 2001 alone, dozens of men, including at least one juvenile, were detained for months solely on the basis of their actual or perceived sexual orientation. Of this group, 22 men and a juvenile, whom Amnesty International has adopted as prisoners of conscience, were eventually sentenced to prison terms. Amnesty International is calling for them to be released immediately and unconditionally.

Men detained for their actual or perceived sexual orientation in Egypt have reported being tortured in police stations, prisons and other detention centres, by members of the security forces and prison staff or other detainees. Detainees are at particular risk of torture and ill-treatment during the initial weeks in custody while they have only limited access to the outside world. The torture they have reported includes being beaten with a stick on the soles of the feet (known as falaka).

# RECOMMENDED ACTION: Please send appeals to arrive as quickly as possible, in English, Arabic or your own language:

- seeking assurances that the five men detained in Buhaira province on allegations of "habitual debauchery" are given regular access to lawyers of their choice;
- urging the authorities to ensure that they are humanely treated in detention and protected from torture and ill-treatment at the hands of police, prison warders or other detainees;
- urging the authorities to ensure that the men are not subjected to forcible anal examinations to determine whether they have engaged in anal sex;
- reminding the government of the absolute prohibition on torture in customary international law and of their commitment to the Universal Declaration of Human Rights, in particular Article 5: "No one shall be subjected to torture or to cruel, inhuman or degrading treatment or punishment".
