Amnesty International believes that the above nine prisoners, all of whom are prisoners of conscience, may now have been brought to trial. They are among a group of more than 20 arrested in June 1990 for signing an open letter to President Rafsanjani, or for their peaceful activities in the Association for the Defence of Freedom and Sovereignty of the Iranian Nation, dissolved on 14 June 1990. A number of them are elderly and in poor health. According to reports received by Amnesty International, the nine prisoners mentioned above were brought to trial on 27 May 1991. No information is available regarding the proceedings, which are believed to have been held <u>in camera</u>, or the outcome of the trial.

In general, political trials in Iran fall far short of international standards for fair trial. Defendants have no access to legal counsel, and proceedings may last only a matter of minutes. Reports indicate that the nine are no longer held in isolation, and are allowed out of their cells for two periods daily. The other members of this group who were released appear not to have been tried.

FURTHER RECOMMENDED ACTION: Telegrams/telexes/airmail letters:

- expressing concern at the continuing imprisonment of these prisoners and urging their immediate and unconditional release as prisoners of conscience;
- seeking clarification of reports that they have been brought to trial, including information as to whether they had access to lawyers for their defence, and the precise charges against them.
