Amnesty International fears that Salim Saberniah and Mustafa Ghaderi, reportedly sentenced to death by the Islamic Revolutionary Court of Tabriz in March 1993, continue to be at risk of execution. According to reports they are still held in Tabriz Prison, but no further information about their current situation is available.

**FURTHER RECOMMENDED ACTION: Please send telegrams/telexes and airmail letters either in English or your own language:**

- reiterating your regret at the reported death sentences passed on Salim Saberniah and Mustafa Ghaderi in March 1993 and urging that the sentences be commuted;
- welcoming reports that the death sentences have so far not been carried out and expressing hope that this may indicate a review of their sentences;
- seeking assurances that they are humanely treated.
