Amnesty International has received reports of the arrest of at least four more people connected to Grand Ayatollah Shirazi, and fears that they may also be prisoners of conscience, at risk of torture or ill-treatment.

On 19 June 1996, Sayed Mehdi Shirazi, the fourth son of Grand Ayatollah Shirazi, was reported to have been arrested from his car between Qom and Tehran. On the same day, Ali al-Rumaythi, a member of Grand Ayatollah Shirazi's staff, is reported to have been arrested in Qom. The following day, Sheikh Hossein al-Dhakeri, another member of Grand Ayatollah Shirazi's staff, is also said to have been arrested in Qom. On 20 or 21 June, Sheikh Azizollah Hassani was also arrested in Tehran. There are conflicting reports as to whether Sheikh Hossein al-Dhakeri has been released, but at least the other three are believed to be held in incommunicado detention.

Most, if not all, of the other 23 referred to above are believed to remain in detention, and to have been subjected to various kinds of torture. Many are now believed to be held in Evin prison in Tehran. At least two are said to have been sentenced to prison terms after unfair trials before the Special Court for Clerics, in which they reportedly had no access to a lawyer. Sheikh Ja'far Ghani has been sentenced to 15 months' imprisonment and Sayed Abdolrasoul al-Musawi has reportedly been sentenced to 6 months' imprisonment. There are also fears that at least some of those who have not yet been tried may face the death penalty, if convicted.

FURTHER RECOMMENDED ACTION: Please send telegrams/express/airmail letters in English, French or your own language:

- seeking information about the current whereabouts and legal status of Sayed Mehdi Shirazi, Ali al-Rumaythi, Sheikh Hossein Dhakeri and Sheikh Azizollah Hassani.
- urging that, if detained, their families be informed immediately of their whereabouts, and that they, and all the others, be granted access to prompt and regular family visits, and to lawyers and doctors of their choice;
- calling for a prompt, thorough and independent investigation into the reports of torture of many of those arrested previously, and urging that all detainees be protected from torture or ill-treatment;
- expressing unconditional opposition to the death penalty, and urging that no-one should be executed;

and if possible, also:

- seek full details of all the charges against those detained, and the evidence against them, including details of any trial proceedings, judgements and sentences;
- urge that all those detained be released if not promptly and fairly tried on recognizably criminal charges. Any prisoners of conscience should be released immediately and unconditionally;
- express concern that the trials of Sheikh Ja'far Ghani and Sayed Abdolrasoul al-Musawi appear not to have met internationally-recognized standards for fair trial, and urging that they be retried promptly and fairly, on recognizably criminal charges, or be released.
