## IRAN Mohsen Sazegara (m), aged 48, journalist Released: Vahid Sazegara (m), his son, student

Vahid Sazegara was released from Evin Prison in the capital Tehran on 9 July. He had been detained without charge since 15 June. He is reported to be in good health.

Journalist Mohsen Sazegara is detained incommunicado at Evin prison. It is not known if he has been charged with any offence. Amnesty International is concerned that he may not be receiving the regular medication he needs for his severe heart condition. He reportedly carried out a 10-day hunger strike following his arrest on 15 June.

Mohsen Sazegara has had two heart operations in the last few years and needs regular medication for his condition. Neither his wife Dr Soheila Hamidnia nor his lawyer, Dr Sho'leh Sa'adi has been allowed to see him since his arrest.

Mohsen Sazegara, an outspoken critic of the Iranian authorities, was arrested after publishing an article on his website, in which he called for "a profound change of the constitution". Amnesty International considers him to be a prisoner of conscience, arrested solely for the peaceful expression of his conscientiously held beliefs.

#### **BACKGROUND INFORMATION**

Amnesty International has for many years documented a catalogue of arbitrary arrests, prolonged and often incommunicado detention, followed in many cases by unfair trials. Vague laws relating to security and defamation have often been used in cases against those who may have expressed dissatisfaction with the government, or those who are known to have political affiliations considered unacceptable by the authorities.

# **RECOMMENDED ACTION:** Please send appeals to arrive as quickly as possible, in Persian, English, French or your own language:

- welcoming the release of Vahid Sazegara on 9 July;

- calling for the immediate and unconditional release of Mohsen Sazegara as prisoner of conscience,

detained solely for the peaceful expression of his conscientiously held beliefs;

- seeking assurances that he will be humanely treated in detention, including being given immediate access to the regular medication he needs;

- calling for Mohsen Sazegara to be granted immediate access to his lawyer, family and any necessary medical treatment;

reminding the authorities that confessions extracted under duress are prohibited by Iranian law and a violation of Article 7 of the International Covenant on Civil and Political Rights (ICCPR), to which Iran is a state party. It states that "No one shall be subjected to cruel, inhuman or degrading punishment";
 calling for all those found to be responsible for the torture of prisoners to be brought to justice in fair trials.
