IRANJavad Rouhani, aged 26, and at least 25 others

According to information received by Amnesty International, Javad Rouhani was released several days ago. However, the whereabouts of at least 25 others reportedly arrested in connection with this case remain unknown.

FURTHER RECOMMENDED ACTION: Please send telegrams/telexes/airmail letters in English, French or your own language:

- welcoming the release of Javad Rouhani;
- asking for clarification of the whereabouts of anyone detained in connection with this case and their current legal status.
