IRANEbrahim Zalzadeh - killed Other writers and journalists in Iran

Amnesty International is dismayed that the Iranian authorities have apparently failed to launch a thorough and impartial investigation into the death of Ebrahim Zalzadeh, thus contravening the UN Principles on the Effective Prevention and Investigation of Extra-Legal, Arbitrary and Summary Executions.

An Iranian newspaper, dated 12 April 1997, reportedly stated that Ebrahim Zalzadeh was killed by thieves after being kidnapped and robbed on 22 February 1997. However, there was no indication that any thorough and impartial investigation into his death had been carried out. Other reports have suggested that Ebrahim Zalzadeh was arrested by officials of the Ministry of Information (Iran's secret service) and later killed.

Amnesty International remains concerned at the pattern of human rights violations against writers and journalists in Iran. The apparent failure by the authorities to conduct an investigation into the death of Ebrahim Zalzadeh reinforces the organization's fears for the safety of other writers and journalists in the country.

Following a final round of appeals, this UA will be closed, and the International Secretariat will continue to monitor developments in the case. Please send a last round of faxes and letters in French, English or your own language:

- urging the Iranian authorities to conduct an immediate, thorough and impartial investigation into the death of Ebrahim Zalzadeh, the methods and findings of which should be made public;
- calling on the Iranian authorities to guarantee the safety of all other writers in Iran, ensuring that they are protected from "disappearance", extrajudicial execution and torture;
- urging that anyone found responsible for human right violations be brought to justice.
