IRAN Zeynab Bayzeydi (f), women's rights activist

On 23 August, Kurdish women's rights activist Zeynab Bayzeydi had her four year sentence of imprisonment and internal exile upheld by an appeal court in West Azerbaijan, according to the Human Rights Activists in Iran website. She was charged with being a member of unauthorised human rights associations and for her activities in support of women's rights. Amnesty International considers her to be a prisoner of conscience, imprisoned solely for the peaceful exercise of her rights to freedom of expression and association.

Zeynab Bayzeydi was sentenced to four years' imprisonment and internal exile to the Turkish-speaking city of Zanjan, 246 km from her home, by Mahabad Revolutionary Court in August 2008. On 10 August Zeynab Bayzeydi went on hunger strike to demand her release. Prison officials promised her that she would be released on bail during her appeal to convince her to stop the hunger strike. On these assurances, she ended the hunger strike on 22 August after twelve days. However, the Mahabad Revolutionary Court failed to grant her bail.

Zeynab Bayzeydi is a member of the Human Rights Organization of Kurdistan (HROK) and the Campaign for Equality that advocates for an end to laws and policies which discriminate against women. She has denied all of her charges except the one related to her work with the Campaign for Equality.

BACKGROUND INFORMATION

The Campaign for Equality is a network of individuals working to end legal discrimination against women. The campaign informs women of their rights, and is aiming to collect one million signatures from the Iranian public to a petition against discriminatory laws. On 27 August, the second anniversary of the Campaign for Equality, Amnesty International renewed its demand that the Iranian authorities cease harassing and imprisoning women's rights defenders and allow them to freely continue their campaigning for the repeal of laws and policies which discriminate against women in Iran.
