Amnesty International fears that the 12 individuals listed above are at risk of "disappearance", torture and execution. All are reported to be members of the banned Iraqi Workers' Communist Party (IWCP) and are believed to have been arrested between October and December 1995.

Amnesty International does not know the exact reasons for their arrest, but the detainees are said to have been suspected of campaigning against the re-election of President Saddam Hussain in the presidential referendum of 15 October 1995. Following the referendum, hundreds of people were reportedly arrested in various parts of the country, particularly in al-Ramadi province, Baghdad, Basra and Karbala'. Those targeted for arrest were believed to have been suspected of having cast their vote against the re-election of President Saddam Hussain. Most of them are believed to be still held.

BACKGROUND INFORMATION

The death penalty is imposed in Iraq for a wide range of criminal and political offences. Certain non-violent political offences such as double membership in political parties, political activity in the army and the refusal of an individual to divulge his/her political activities, are also punishable by death. Although Iraq's Penal Code does not provide for the death penalty as a mandatory punishment for membership of a banned political party, members of banned political parties and other suspected government opponents have been executed in the past for their political activities.

RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express/airmail letters in English or your own language:

- requesting details of the whereabouts of the 12 reported members of the Iraqi Workers' Communist Party (naming some or all), detained in connection with the presidential referendum of 15 October 1995;
- seeking assurances that they are being treated humanely in accordance with international standards;
- requesting details of the charges against them and the legal procedures followed in their cases;
- urging their immediate release unless they are to be charged with recognisable criminal offences;
- requesting details of any other people detained in connection with the referendum.
