IRAQ

The people of Iraq and surrounding countries

---

On 20 March, United States, United Kingdom and other allied forces launched military action against Iraq.

Amnesty International fears that the war may result in a human rights and humanitarian catastrophe, and is calling on all governments involved to adhere strictly to their obligations under international human rights and humanitarian law.

There are, in particular, grave concerns for the safety of Iraqi civilians, including children. Civilians are in danger of being targeted by military attacks, or becoming the innocent victims of the use of indiscriminate attacks or prohibited weapons. The disruption of delivery of essential services and supplies could also have severe humanitarian consequences.

The military action may also trigger widespread human rights abuses by the Iraqi authorities, armed opposition groups and all those involved in military action. In such an environment women may be at particular risk.

**RECOMMENDED ACTION: Please send appeals to arrive as quickly as possible, in English or your own language, urging all governments involved in military action in Iraq to:**

- ensure that civilians or civilian objects are not targeted in any attacks;
- prohibit the use of chemical, biological or nuclear weapons or other inherently indiscriminate weapons such as anti-personnel land mines and cluster weapons;
- ensure that all civilian detainees are treated humanely and are able to challenge the lawfulness of their detention, and if not charged or tried within a reasonable time they should be released;
- ensure the security and humanitarian needs of the Iraqi population are fully met, including the provision of food, water, shelter, sanitation and medical care;
- support and facilitate the deployment of human rights monitors in Iraq as soon as the security situation permits.
