'Ala' al-Saftawi, who was arrested on 6 February 1995 with five other colleagues from *Istiqlal* newspaper, was released on 2 March, on the orders of the security police (*mukhabarat*). He had not been charged, given access to a lawyer, nor brought before a judge. His colleagues, listed above remain in detention.

Amnesty International is concerned at the lack of legal procedure in these arrests and detentions. It believes that at least 47 people remain in detention without charge, most of whom have not been given access to lawyers or brought before a judge.

Three others, Yasser Hussain, Azzam al-Hamalawi and Jaber al-Karinawi, also arrested in early February were released on 28 February.

## FURTHER RECOMMENDED ACTION: Please send telegrams/faxes/express and airmail letters:

- calling for the immediate release of the five journalists and 42 others unless they are to be charged with a recognizably criminal offence and promptly brought to trial according to international standards for fair trial;

- calling on the PA to ensure that all families of detainees are immediately notified of the detention and that all detainees have prompt access to their families, lawyers and independent doctors and to judges, as required by international human rights standards.
