ISRAEL AND THE

OCCUPIED TERRITORIES: Muhammad Ya'qub 'Abd al-Qader al-Nubani

Amnesty International is seriously concerned at the allegations of torture and the continued detention without charge of Muhammad Ya'qub 'Abd al-Qader al-Nubani (ID No. 959233750), a 27-year-old Palestinian from the village of Mazari' al-Nubani near Ramallah on the West Bank. Muhammad al-Nubani was arrested on 22 April 1993 and, according to a lawyer, who last visited him on 5 July 1993, he is still being held in interrogation in Ramallah Prison. He is apparently suffering from severe back pain, headaches, stomach pain and shortness of breath.

Muhammad al-Nubani was arrested by Israeli forces in the town of Bir Zeit on the afternoon of 22 April 1993. He says he was told to come out of the house and to lie on the ground, which he did. Soldiers then allegedly kicked him and beat him with their guns on his head and body, until he started bleeding from his head, nose and mouth.

He was taken to Ramallah prison, where he says he spent five minutes with a doctor who cleaned the blood from his face and body, but did not examine him further. Medical reports indicate that Muhammad al-Nubani suffered from vertebral disc problems and gastritis prior to his arrest.

Muhammad al-Nubani did not see a lawyer until 20 May 1993. On 9 June he gave his lawyer an affidavit in which he alleged that he had been in a painful position on a low chair with his hands and feet tied. He was deprived of sleep, being permitted to sleep about one hour in every 80. In a second statement given on 22 June, he says that he was not allowed to have a bath until 40 days after his arrest and that his treatment in detention had not changed. He said that one of his interrogators had told him "We do not want to kill you, but we want you to see death in your eyes". During the first weeks of his detention he also appears to have been hooded.

Muhammad al-Nubani has apparently been interrogated in connection with the handling of weapons. Press reports after his arrest claim that a 9 mm pistol was found in his possession. They allege that he was the commander of a Fatah cell (Fatah is a faction of the Palestine Liberation Organization) in the region, and that he had been sought by the authorities since 1991.

Amnesty International is calling for an immediate and impartial investigation

into the allegations of the torture of Muhammad al-Nubani during his arrest and detention. Any form of torture or ill-treatment should stop immediately. He should also be allowed to see an independent doctor of his choice.

Amnesty International opposes the detention without charge or trial of political prisoners and believes that Muhammad al-Nubani should be released if he is not to be charged with a recognizably criminal offence and given prompt and fair trial.
