ISRAEL AND THE OCCUPIED TERRITORIES: Ahmad Sulayman Musa Qatamesh

Amnesty International remains concerned at allegations that Ahmad Sulayman Musa Qatamesh (ID card No. 98370264), arrested on 1 September 1992, has been tortured or ill-treatment while under interrogation. He is currently held in Ramallah Prison. His detention was extended for a further 30 days on 23 September 1992. Amnesty International is also seeking information about the arrest of Suha Barghouthi, the wife of Ahmad Qatamesh, on 24 September 1992.

Ahmad Qatamesh was not allowed to meet a lawyer until 23 September 1992. On 24 September 1992 he told his lawyer that since his bail hearing on 10 September 1992, he had continued to be subjected to prolonged sleep deprivation. His lawyer confirmed that he was extremely tired. He also said that he was being made to sit throughout the day on a low chair with his hands shackled behind his back, although he said that he was no longer being hooded because he had had difficulty breathing. He complained of a constant, severe headache and of other pains, but said that he was refusing medication until he was allowed to sleep. Ahmad Qatamesh stated that on at least three occasions interrogators had told him that he should have been killed rather than detained, and that once he was told that "measures would be taken" to ensure that "something" happened to him. Ahmad Qatamesh remains under interrogation.

Suha Barghouthi, Ahmad Qatamesh's wife, was also arrested on 24 September 1992, and was taken to the Moscobiyyah detention centre in Jerusalem where she is apparently being interrogated about her husband's activities. The couple have a three-year-old daughter.

Amnesty International understands that Ahmad Qatamesh is being interrogated in connection with membership and activities on behalf of the Popular Front for the Liberation of Palestine. It is continuing to seek information on the exact reasons for his arrest and his current legal situation. It is also seeking similar information about Suha Barghouthi.

Amnesty International continues to call for an immediate investigation into Ahmad Qatamesh's allegations of torture or ill-treatment and is also seeking immediate assurances from the Israeli authorities that throughout any remaining period of interrogation and detention he will be treated in conformity with international standards for the treatment of detainees.
