ISRAEL/OTSamer Fawzi 'Awartani, aged 34, hospital administrator

Hospital administrator Samer Fawzi 'Awartani was arrested by the Israeli security forces on 7 May as he returned from a medical conference in Oxford, England. He is now reportedly detained without charge or trial, and he is at grave risk of torture.

He is now held in Tah Tikva detention centre, inside the Occupied Territories. He has not been allowed to see his lawyer or his family, in contravention of the basic principles of international law. On 14 May his lawyer discovered that an Israeli court had extended Samer's detention by another two weeks without informing him or his client.

Samer Fawzi 'Awartani is the administrative director of Rafidia Hospital, in the West Bank city of Nablus. He had gone to England to present a paper at a conference organised by the British government on "empowerment of patients and health care management". On his return he was arrested at the Allenby Bridge crossing point between the West Bank and Jordan.

RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express/airmail letters in English/Hebrew or your own language:

- asking the authorities to release Samer Fawzi 'Awartani immediately unless he is to be charged with a recognizable criminal offence;
- expressing concern at reports that other Palestinian detainees have been tortured or ill-treated during interrogation, and asking the authorities to ensure that Samer Fawzi 'Awartani is treated in accordance with international standards;
- reminding the authorities that while he is in custody Samer Fawzi 'Awartani has the right of access to a lawyer of his choice and his family.
