UA 160/02 Torture/ill-treatment

Marwan Barghouti was arrested in Ramallah by Israeli security forces on 13 April. He has reportedly been tortured and otherwise ill-treated while being interrogated by the General Security Services (GSS). He was held in incommunicado detention between 18 April and 15 May, but is now allowed visits from his lawyers, but not his family.

Following his arrest, Marwan Barghouti was taken to the Moskobiyeh detention centre in Jerusalem. He was reportedly deprived of sleep and tortured using a method known as *shabeh*. He was forced to sit on a small sloping chair, where the front legs are shorter than the back legs, while his hands and feet were shackled.

He has now been transferred to Petah Tikvah detention centre in Israel. He reportedly continues to be intensively interrogated and tortured in *shabeh*. Over a period of 72 hours, he has reportedly only been allowed to sleep for two hours per day. He has also alleged that his interrogators have made threats to kill him and his son, who is being held in Shikma Prison in Ashkelon, Israel.

Marwan Barghouti is the Secretary General of Fatah, the dominant political force of the Palestinian Authority, and a member of the Palestinian Legislative Council. Fatah has carried out many attacks on Israelis, including Israeli civilians, in the Occupied Territories. He is also suspected of having close links with the al-Aqsa Martyrs Brigade, a Palestinian armed group linked with Fatah, who have been responsible for many armed attacks and suicide bombings against Israelis, including Israeli civilians, in Israel and the Occupied Territories.

BACKGROUND INFORMATION

Amnesty International is concerned at reports it has received of Palestinians being tortured and otherwise ill-treated in Israeli prisons and detention centres. Since incursions into the Occupied Territories by the Israeli Defence Forces on 27 February, thousands of Palestinians have been arrested and detained.

RECOMMENDED ACTION: please send appeals to arrive as quickly as possible in English, Hebrew or your own language:

- expressing concern that Marwan Barghouti is reportedly being tortured and otherwise ill-treated during interrogation;
- asking that he be treated humanely according to international human rights treaties, such as the Convention against Torture and Other Cruel, Inhuman or Degrading Treatment or Punishment, which Israel has ratified, prohibiting torture or other ill-treatment;
- asking the Israeli authorities to set up an independent investigation into the torture allegations, and make the results of this investigation public;
 calling for anyone who has ordered or carried out torture or ill-treatment to be brought to justice;
- stating that Amnesty International has consistently condemned attacks against civilians carried out by *Fatah* and other armed Palestinian groups, but reminding the Israeli authorities that the Convention against Torture states clearly that: "No exceptional circumstances whatsoever, whether a state of war or a

threat of war, internal political instability or any other public emergency, may be invoked as a justification of torture." - reminding the Israeli authorities that while he is in custody Marwan Barghouti should be permitted prompt and regular access to his family.
