# Further information on UA 277/95 (MDE 16/05/95, 29 December 1995) - Legal Concern / Possible prisoner of conscience

#### JORDANLeith Shubeilat, head of the Engineers' Union

Leith Shubeilat, the head of the Engineers' Union, was freed under a special amnesty on 8 November 1996.

Leith Shubeilat had been arrested on 9 December 1995 and been charged with *lèse majesté* against King Hussein bin Talal. He had condemned King Hussein's words of praise and expressions of friendship for Yitzhak Rabin, the Prime Minister of Israel, assassinated on 4 November 1995. Leith Shubeilat was brought to trial before the State Security Court and sentenced to three years' imprisonment in March 1996. This sentence was upheld by the Court of Cassation in May.

On 8 November King Hussein bin Talal drove to Swaqa Prison, 80 kilometres south of Amman and personally informed Leith Shubeilat of his release. He was informed that 200 other prisoners, including political prisoners, would also be freed by amnesty. King Hussein then drove Leith Shubeilat back to his mother's house in Amman.

Amnesty International welcomes the release of Leith Shubeilat. The organization considered him to be a prisoner of conscience, detained solely because of his opposition to the peace agreement with Israel and his other peaceful political activities.

On 12 November King Hussein sent a letter to the Prime Minister ordering that charges be dropped against 253 people facing trial after riots against rises in the price of bread in August. The King's amnesty was said to extend to other prisoners not considered a threat to public security or whose term already served was considered sufficient punishment.

The list of those included in the amnesty is apparently being drawn up by the Prime Minister and the Minister of Justice.
