## LEBANONAhmad Rida Yassin, 68

Ahmad Rida Yassin, a 68-year old Lebanese national, may face imminent execution after a plea for clemency was turned down by the Lebanese Amnesty Committee. In October 1997, the Criminal Court of Cassation upheld the conviction of Ahmad Rida Yassin by the Sidan Criminal Court for murdering Zahra 'Attiyah.

The Criminal Court of Cassation was of the opinion that Ahmad Rida Yassin was entitled to have his sentence reduced. However, it was prevented from granting this right by the provisions of Article 2 of the 1994 death penalty Law No.302. Law No.302 suspended Articles 547 and 548 of the Penal Code which proscribe respectively up to 20 years' imprisonment with hard labour, and life imprisonment with hard labour for the crime of murder, and replaced the sentence with the death penalty.

It is not clear, in the circumstances, whether the sentence can still be commuted by the President of the Republic in accordance with Article 455 of the Code of Criminal Procedure and Article 152 of the Penal Code. The death penalty can only be carried out after the approval of the President of the Republic.

## BACKGROUND INFORMATION

Since the expansion of the death penalty in March 1994, about 30 death sentences have been passed by Lebanese courts, and 12 judicial executions were carried out by December 1997. This compares with only three executions carried out in over three decades prior to the 1994 death penalty legislation. The *Conseil Supérieur de la Magistrature* (Supreme Judicial Council) has reportedly appealed to the President of the Republic for a special clemency.

Amnesty International has urged the Lebanese authorities to review the 1994 death penalty law with a view to phasing out this punishment, and has called on the Lebanese authorities to ratify the Second Optional Protocol to the International Covenant on Civil and Political Rights, aiming at the abolition of the death penalty.

While Amnesty International recognizes the responsibility of governments to bring the perpetrators of crimes to justice according to international standards, it is opposed in principle to the application of the death penalty, as the ultimate form of cruel, inhuman, and degrading punishment and a violation of the right to life. The possibility of miscarriage of justice always remains, and execution cannot be revoked once it has been carried out.

- -calling on the Lebanese authorities to ratify the Second Optional Protocol to the International Covenant on Civil and Political Rights.
