PALESTINIAN AUTHORITYFathi Subuh, 43, lecturer in education

Fathi Subuh remains in detention in Gaza Central Prison. On 6 September 1997, the Palestinian High Court of Justice considered a habeas corpus petition, seeking his release. His lawyer, Raji Sourani, reported that Fathi Subuh had been subjected to severe torture and ill-treatment during his detention at Tel al-Hawa Prison, run by the Preventive Security Service (PSS), in Gaza. He was hung from behind by his hands with his feet off the ground, forced to balance for long periods on his toes, and subjected to beating, sleep deprivation and hooding.

In the hearing the Attorney-General, representing the Palestinian Authority, did not respond to Fathi Subuh's allegations that he had been subjected to torture and ill-treatment. He informed the court that the case was not under his jurisdiction, but under the jurisdiction of the State Security Court. The Attorney-General submitted a document to the court indicating that the State Security Court had extended Fathi Subuh's detention on 3 July. He told the court that Fathi Subuh was accused of having passed information to "the other side", and stated that the Palestinian Authority could not release him because of a fear that he would establish contact with "the other side". The Attorney-General also stated that Fathi Subuh was also suspected of having sexually harassed female students at al-Azhar University.

This was the first time that Fathi Subuh's lawyer had been informed that the case was not being handled by the Attorney-General or had seen an extension of detention order from the State Security Court.

In spite of the allegations of torture made by Fathi Subuh's lawyer, the court did not ask to see Fathi Subuh personally in order to verify these claims. The court deferred its decision until 6 October.

In a meeting this month, Colonel Muhammad Dahlan, the head of PSS in the Gaza Strip, informed an Amnesty International delegate that Fathi Subuh was being held on charges that included rape and spying. The delegate asked for details of the evidence against Fathi Subuh, but Colonel Muhammad Dahlan was unable to provide this. Fathi Subuh's lawyer has not been informed by the Palestinian Authority that any charges have been filed against him.

Fathi Subuh's wife has been allowed to visit him once every fortnight for about half an hour.

Recently an Amnesty International member received a letter in Arabic from the Legal Adviser to Preventive Security responding to his Urgent Action appeal. The Legal Adviser stated that Fathi Subuh had not been arrested on political grounds, but did not detail the precise grounds for his arrest. He also assured him that Fathi Subuh was being well treated and that all legal procedures were being followed in the case, which had been transferred to the Attorney-General. The Legal Adviser suggested that it would be better if the AI member expressed

his concern to the Israeli Government about the "illegal pressure" which it was placing on the Palestinian Authority to arrest Islamic militants.

FURTHER RECOMMENDED ACTION: Please send telegrams/faxes/express/ airmail letters in English, Arabic or in your own language.

- noting that Fathi Subuh has now been held for more than two months, without charge or trial;
- expressing deep concern at the allegations of torture and ill-treatment of Fathi Subuh during his detention in Tel al-Hawa Prison and calling for an investigation into these allegations;
- asking what the precise reasons are for Fathi Subuh's arrest;
- stating that you continue to consider Fathi Subuh to be a prisoner of conscience, detained solely for his alleged critical attitude towards the Palestinian Authority;
- calling for his immediate and unconditional release;
- stating that Amnesty International has consistently appealed to the international community, particularly Israel and the United States, to refrain from pressurizing the Palestinian Authority to arrest persons, unless they are to be charged with a recognizable criminal offence and given a fair and prompt trial.
