The three men named above were brought to court in mid-June, after they were reported to have refused to sign pledges to liaise with the authorities before carrying out any public activity. Amnesty International is concerned that they may be prisoners of conscience, held solely for the non-violent exercise of their right to freedom of expression and association.

All three are reported to have been allowed access to their families and lawyers. They are reported to have been well treated, and allowed books and newspapers. Their lawyers were reportedly present at the court session; however, it is still not clear what charges have been brought against them.

Abdel Rahman al-Lahem was reportedly released from prison in May. He was arrested on 17 March after he appeared on the *al-Jazeera* TV station criticising the 15 March arrests of Dr Matrouk al-Falih and other prominent academics who had criticised the government National Commission on Human Rights (NCHR) for its lack of independence.

## **BACKGROUND INFORMATION**

Due to the secrecy of the Saudi Arabian justice system, trials are often held behind closed doors. In the rare instances when people are charged and brought to trial, the proceedings invariably fail to meet the most elementary standards of fairness.

Many thanks to all those who sent appeals. Amnesty International will continue to monitor the situation of the detainees, and take further action as necessary. Please send a final round of appeals to arrive as quickly as possible, in Arabic or your own language:

- calling for the three detainees (naming them) to be released immediately and unconditionally if they are held solely for their criticism of the NCHR or for planning to set up their own human rights organisation;
- calling for anyone charged with a recognizably criminal offence to be given a prompt and fair trial.
